

**CONSTITUTION OF  
Maya Bowhunters of Roseville Inc.**

**ARTICLE 1. NAME**

The name of this organization is called Maya Bowhunters of Roseville Inc. also known as Maya Archers.

**ARTICLE 2. PURPOSE**

The purpose of this organization shall be to perpetuate the ancient and honorable tradition of archery in all facets, to actively promote the spirit of good fellowship and sportsmanship among archers, to encourage the sport of hunting all legal game with bow and arrow, to promote educational programs to acquaint the public on aspects of hunting, field archery, safety and conservation.

**ARTICLE 3. MEMBERSHIP**

Members shall be classified in seven groups: Senior, Adult, Youth, Family, Honorary Life, Associate, Active Military, Full Time College Students, and Non -Working Adult/Family

1. Senior Membership maybe granted to anyone past his or her fifty-fifth (55) birthday upon payment of regular dues as prescribed in the Bylaws.
2. Adult Membership may be granted to anyone past his or her eighteenth (18) birthday upon payment of regular dues as prescribed in the Bylaws.
3. Youth Membership may be granted to anyone between the age of twelve (12) and seventeen (17). This includes all youth members in same household with the written consent of parent or guardian upon payment of regular dues as prescribed in the Bylaws.
4. Family Membership maybe granted spouse/partner and children under the age of twenty (20) living in the same household upon payment of regular dues as prescribed in the Bylaws.
5. Honorary Life Membership may be granted to any person for merit or service as prescribed in the Bylaws.
6. Associate Membership may be granted to any adult whose residence is fifty (50) miles from the home range upon payment of regular dues as prescribed in the Bylaws. Active Military and full time college students shall fall under this classification.
7. Non Working Adult/Family Membership and dues as prescribed in the Bylaws.

#### **ARTICLE 4. BOARD OF DIRECTORS**

Shall consist of a board will be the President, Vice President, Secretary, Treasurer, Range Manager, and 3 elected members. All must be a member of Maya Bowhunters for at least 2 years and maintain a membership of NFAA/CBH/NORCAL Region. The Board of Directors may appoint other officers as necessary as prescribed in the Bylaws. The Board of directors shall manage the activities, policies, including finances (Up to \$500 for emergency purposes) and property of this organization as prescribed in the Bylaws.

#### **ARTICLE 5. MEETINGS**

There shall be a monthly membership meeting of MAYA BOWHUNTERS to be held the 1st Tuesday of each month at 7:00 pm. Maya Board meetings will be held on the 4th Tuesday of each month at 6:30 pm.

#### **ARTICLE 6. AMENDMENTS TO CONSTITUTION**

All proposals to amend the constitution must be presented in written form to the Board of Directors for review on or before October 1st of the calendar year. Proposed amendments will be presented to full Membership by November 1st, through Maya Newsletter, email, or monthly Club meeting. This constitution may be amended by a two thirds (2/3) majority vote of the members present at the December Club meeting.

#### **ARTICLE 7. AMENDMENTS TO BYLAWS**

All proposals to amend the BYLAWS must be presented in written form to the Board of Directors for review. Proposals will be presented at the next club meeting. Time should be allowed to publish the amendments in the next newsletter for full membership review. After completion of above they will be voted on at the following Club meeting. The Bylaws may be amended by a two thirds (2/3) majority vote.

#### **ARTICLE 8. REVIEW OF CONSTITUTION AND BYLAWS**

Constitution and Bylaws shall be reviewed on the even number years, every 2 years before the end of Fiscal Year (June 30th).
