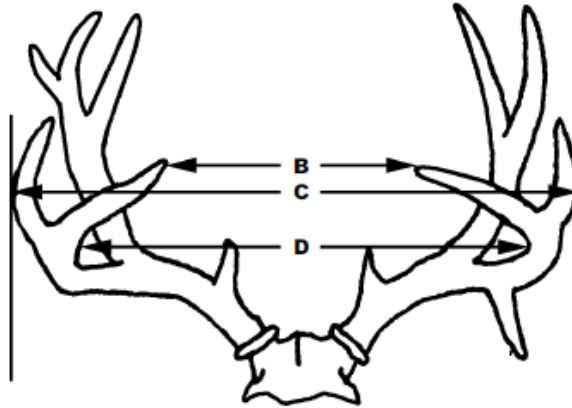
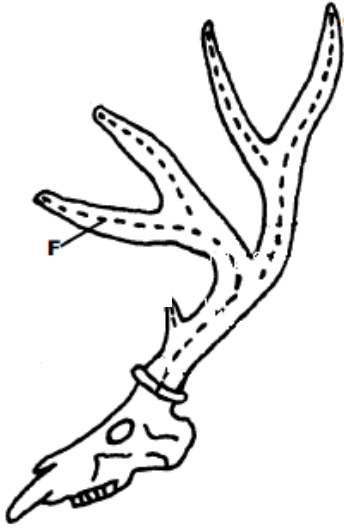


TYPICAL MULE DEER AND BLACKTAIL DEER

BRIEF INSTRUCTIONS FOR MEASURING TYPICAL MULE AND BLACKTAIL DEER

Measurements must be made with a flexible steel tape or steel cable and recorded to the nearest one-eighth of an inch. To simplify addition, please enter fractional figures in eighths and in proper fractions.

A. Number of Points on each antler. To be counted a point, a projection must be at least one inch long AND, at some location at least one inch from the tip, the length of the projection must exceed its width. Beam tip is counted as a point but not measured as a point.

B. Tip to Tip Spread is measured between tips of main beams.

C. Greatest Spread is measured between perpendiculars at a right angle to the center line of the skull at widest part whether across main beams or points.

D. Inside Spread of Main Beam is measured at a right angle to the center line of the skull at widest point between main beams. Enter this measurement again in "Spread Credit" column if it is less than or equal to the length of longer main beam. If greater, enter longer main beam length for Spread Credit.

F. Length of Main Beam is measured from the center of the lowest outside edge of burr over outer curve to the most distant point of the main beam. Begin measuring at the location on the burr where the center line along the outer curve of the beam intersects the burr.

Drying Period: To be eligible for entry in the Club Big Game Records, a trophy must first have been stored under normal room temperature and humidity for at least 60 days after date of kill. No trophy will be considered which has been altered in any way from its natural state.

ENTRY REQUIREMENTS FOR MAYA BOWHUNTERS BIG GAME RECORDS & AWARDS PROGRAM

1. **Scoring form** completed by active member and submitted to Hunting VP of Maya Bowhunters by February 1st.
2. **Completion of 'Fair Chase Affidavit'** on the back of the scoring form.
3. **At least one photo of the antlers.** Three photos preferred (a view from the front side, a view from the left side and a view from the right side). A field photo is also requested, if possible. Digital photos preferred.

RULES OF FAIR CHASE

The term "Fair Chase" shall not include the taking of animals under the following conditions:

1. Helpless in a trap, deep snow or water, or on ice.
2. From any power vehicle or power boat.
3. By spotlighting at night.
4. By the use of any tranquilizers or poisons.
5. While inside escape-proof fenced enclosures.
6. By the use of any power vehicle or power boats for herding or driving animals, including use of aircraft to land alongside or to communicate with or direct a hunter on the ground.
7. By the use of electronic devices for attracting, locating or pursuing game or guiding the hunter to such game or by the use of a bow or arrow to which any electronic device is attached.

The fair chase concept does, however, extend beyond the hunt itself; it is an attitude and a way of life based in a deep-seated respect for wildlife, the environment, and for other individuals who share in bowhunting.
