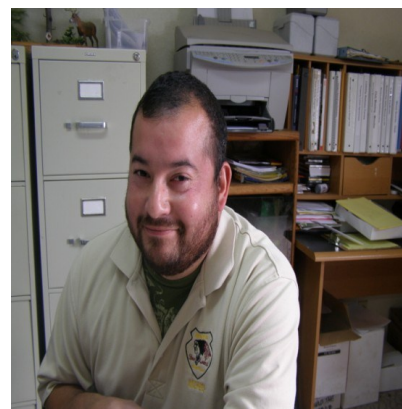

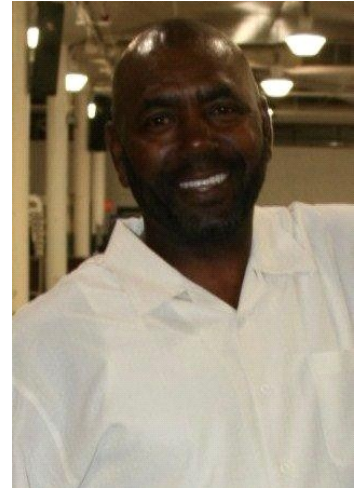

Recently we mailed out the 2012-2013 Membership Renewals to all Life, Family, Adults, Youth, Senior, Associate, Full Time Military, Full Time College Student members. ## Nor Cal, By Robert Moore

**What is Nor Cal? The full name for this regional group is Nor Cal Bowhunters. They represent the areas 7 archery/bowhunting clubs and 2 archery pro shops to California Bowmen Hunters State Archery Association (CBHSAA). CBHSAA and Nor Cal are chartered to the National Field Archery Association (NFAA).**

**What do Nor Cal and CBHSAA do for Archery or Bowhunting? There are many facets to their representation of Archery and Bowhunting. CBHSAA is “Dedicated to Promoting and Protecting the Archery and Bowhunting Heritages”. This statewide organization speaks for California Archers and Bowhunters in matters concerning Legislation and Regulation since 1943. The Legislative committee of CBHSAA includes a Coordinator, 6 state area reps and each region group has one legislative representative. Archery is a shooting sport so at times issues arise to limit or exclude the shooting of Bows and Arrows for any purpose. CBHSAA will pursue those actions for the benefit of all Archers and Bowhunters. Future meeting dates, July 11th and August 8th, 7pm at the Maya Clubhouse.**



**The CBH/SAA state broadhead championship was held at Tejon Ranch on memorial weekend. Reports of a record 198 shooters participated in this two day event. The Big Game Opportunity Drawing was held with all 250 tickets being distributed.**

**The Fish and Game Commission (FGC) has adopted this year’s big game regulations at their April meeting. Department of Fish and Game (DFG) have submitted proposals to FGC on upland bird regulations at the May 23<sup>rd</sup> meeting. One change up for consideration is adding days to the Archery Pheasant season so its 30 days long. The Sport Fishing Conservancy has made a request to FGC to possibly eliminate Bowfishing for Sharks by changing section 28.95 of the ocean fishing code. This section of code also specifically states what species can be bow fished in ocean waters. The actual language change has not introduced so it is not know if it will only pertain to sharks.**

**It’s apparent that the Humane Society of the United States has severely ramped up its efforts in its pursuits of eliminating all hunting, fishing and pet ownership as stated by the organizations president Wayne Pacelle.**

### **CBHSAA Alert:**

**State Senate bill SB1221 has been “gut and amended” from an air pollution bill to now eliminate the use of dogs in the hunting of bears and bobcats. The bill was modified by Senator Ted Leiu and co authored by Darryl Steinberg with the help of the Humane Society of the United States (HSUS). The bill passed out of the Senate and is now in the Assembly Natural Resources, Water and Parks Committee with its first hearing set for June 26th. ## Hunting VP - Dave Baker

Today is a good day for the future of wildlife in America. The court victory which upheld the constitutionality of the Congressional wolf delisting is now final. This has been a long time coming.

Here is what is happening: No appeal has been filed with the Supreme Court on the Congressional Wolf delisting challenge. This means that all legal remedies have been exhausted by the parties challenging the wolf delisting provisions. The delisting language is now the law of the land. Wolf management in Idaho and Montana can continue without the cloud of this litigation.

We are grateful to the other conservation organizations that joined as parties in the wolf litigation. Certainly this was the effort of not a few, but of many. In particular, we are grateful to attorney Ted Lyon for his tireless work on the lawsuit on behalf of the conservation organizations and for his work in obtaining passage of wolf delisting legislation in Congress.
